5. Parties to the dispute shall pay the abovementioned arbitration fees, related to consideration of the claim filed by xxxxxxxx and the counterclaim filed by xxxxxxxx, in equal parts.
6. Arbitration fees shall be paid to the bank accounts of the AICAC or its official representatives. The banking details shall be provided to the parties.
7. This Act immediately comes into force when it is announced to the parties to the dispute.
8. Instructions of this Act must be fulfilled by the parties to the dispute within 10 days of the receipt of it.
9. Hereby the AICAC arbitral tribunal expected to settle the commercial dispute in the arbitration case No. xxx-xx/GBU/UKL, is officially informing the parties of the possible unfavorable consequences provided for in Articles 48-54 of the AICAC Regulations should the parties fail to pay the above-mentioned arbitration fees.
