REGULATION
of AMERICAN INTERNATIONAL COMMERCIAL ARBITRATION COURT
"ON SPECIAL TITLES AND RANKS IN THE AICAC"

*Adopted by the Congress of the American International
Commercial Arbitration Court (USA)
- Resolution N 02/11-10 of 07.07.2010*

In accordance with the Statute of the AICAC and the Regulation "On American International Commercial Arbitration Court", special titles and ranks are established for officials, employees, official representatives and partners of the AICAC. The list of these titles and ranks, as well as the procedure for giving, withdrawing and using them are established by this Regulation.

1. Special titles and ranks of the AICAC are established in order to fix the criteria determining functional differentiation, official hierarchy and qualification status and the level of effectiveness of the persons directly connected with the system of functioning of the AICAC.
2. Special titles and ranks of the AICAC are reasonably given and risen by the President of the AICAC.
3. In the AICAC official (administrative), qualification and representative special titles and ranks are given.

9. Official (administrative), qualification and representative special titles and ranks are lowered or withdrawn from the corresponding persons by order of the President of the AICAC on his initiative or on the proposal of managing officials of the AICAC, if there are facts in evidence of:

- lack of professionalism or incompetence displayed by the corresponding persons;
- commitment of actions discrediting the name and authority of the AICAC;

- commitment of actions discrediting honor and dignity of clients, partners or employees of the AICAC;
- commitment of actions causing damage to property interests of the AICAC, as well as causing moral or material damage to customers, partners or employees of the AICAC;
- offenses inconsistent with the status of a partner or employee of the AICAC.
