* - In the absence of a state in the lists of countries, predetermining the factor for the calculation of remunerations of arbitrators, the issue of including the state into a particular group of countries, as well as the application of the corresponding coefficient is resolved by the arbitral tribunal considering the particular dispute.

** - Primary calculation is based of a defendant's country, and the final payment is adjusted for the country of an actual payer of the fees.

*** - Decreasing factors shall be taken into account when calculating the amount of remunerations for arbitrators of arbitral tribunals considering disputes with the amount of claims not less than 1 000 000.00 US dollars.
